



## The Aon Ireland MasterTrust Privacy Notice

**Aon Solutions Ireland Limited** provides services and products in relation to your employment and membership of your pension scheme. The **Aon Ireland MasterTrustee DAC** acts as the Trustee of The Aon Ireland MasterTrust and is responsible for the administration and management of The Aon Ireland Master Trust. We are committed to protecting your privacy. This commitment reflects the value we place on earning and keeping the trust of our customers, business partners, and others who share their personal information with us.

### What does this Privacy Notice do?

This Privacy Notice ("Notice") explains **Aon Solutions Ireland Limited's** and **The Aon Ireland MasterTrustee DAC's** information processing practices. It applies to any personal information you provide to us and any personal information we collect from other sources. This Notice is a statement of our practices and of your rights regarding your personal information. This is not a contractual document, and it does not create any rights or obligations on either party, beyond those which already exist under data protection laws.

This Notice does not apply to your use of a third party site linked to The Aon Ireland MasterTrust member website.

### Who is responsible for your information?

Throughout this Notice:

- **"Aon"** refers to **Aon Solutions Ireland Limited** including its affiliated companies and subsidiaries.
- **"The Trustee"** refers to The Aon Ireland MasterTrustee DAC.

Together **Aon** and **The Trustee** are also referred to as "we", "us", or "our".

**Aon** and **The Trustee** are responsible for your personal information that we collect from or about you. Each is a separate and independent *controller* for the purposes of data protection laws. **Aon** also acts as a service provider to **The Trustee** in some circumstances, such as in relation to the provision of administration services for The Aon Ireland MasterTrust, and it acts as the Trustee's *processor* in these circumstances.

### When and how do we collect your information?

We collect personal information in the following ways:

We also collect personal information about your spouse, partner or other immediate family member where you have named such individuals as beneficiaries to your pension. Where this additional information is provided to us, we will handle it in accordance with this Privacy Notice. However, as we will not be collecting the information from the beneficiary directly, you are responsible for informing your beneficiaries that we may process their information for these purposes, and providing them with a copy of this Privacy Notice.

### What information do we collect?

#### *Information you provide to us*

When we provide The Aon Ireland MasterTrust services and website in our roles as separate and independent data controllers, we may collect personal information such as:

More information about the personal information collected, together with the purpose and legal basis for collecting the information is provided below.

We will not collect any special categories of data unless this is required. Special categories of data include a number of types of data relating to: race or ethnic origin; political opinions; religious or other similar beliefs; trade union membership; physical or mental health; sex life or sexual orientation.

Before collecting and/or using any special categories of data we will establish a lawful basis which will allow us to use that information. This will typically be:

- your explicit consent;
- the establishment, exercise or defence by us or third parties of legal claims; or
- a specific exemption provided for under Irish law, such as the processing of health data in relation to life assurance policies and pension schemes.

If you provide personal information about other individuals such as dependents, you must obtain their consent prior to your disclosure to us.

#### *Information **Aon** collects over The Aon Ireland MasterTrust website*

For purposes of this Notice, "website" includes our mobile applications.

**Aon** may ask you for some or all of the following types of information when you register on The Aon Ireland MasterTrust website, request services, manage your account, or access various content and features. This includes, but is not limited to:

- Contact information, such as name, e-mail address, postal address, phone number and mobile number;
- User name, password, password reminder questions and password answers;
- Communication preferences.

The Aon Ireland MasterTrust member website may utilise cookies and other tracking technologies, including to ensure basic that functionality of our site is maintained, which we call strictly necessary cookies to. We may also want to set either first- or third-party optional cookies to improve the experience on The Aon Ireland MasterTrust member website. To view the categories of cookies on The Aon Ireland MasterTrust member website, please utilize our OneTrust Cookie Preference Center, which may be found as a footer of the website and/or when you first visit The Aon Ireland MasterTrust member website. We ensure that our use of cookies is in line with local legal and regulatory requirements, and as such have ensured that the behaviour and appearance of our Cookie Preference Center is based on the geolocation of your IP address.

#### **How do we use your personal information?**

The following is a summary of the purposes for which we use personal information. More information about the personal information collected for each of our services, together with the purpose and legal basis for collecting the information is provided to you below.

If we wish to use your personal information for a purpose which is not compatible with the purpose for which it was collected for, we will ensure that this is justified by an appropriate lawful basis for processing. In all cases, we balance our legal use of your personal information with your interests, rights, and freedoms in accordance with applicable laws and regulations to make sure that your personal information is not subject to unnecessary risk.

#### *Legal basis*

All processing (i.e. use) of your personal information is justified by a "lawful basis" for processing. In limited circumstances, we may process your personal information with your consent, for example where we require you to provide special categories of data such as medical details that impact your retirement age, or where we are required to obtain your prior consent in order to send you marketing communications.

### How long do we retain your personal information?

How long we retain your personal information depends on the purpose for which it was obtained and its nature. We will keep your personal information for no more than the time required to fulfil the purposes described in this Notice unless a longer retention period is permitted by law. Typically we would retain personal information for no more than twenty years beyond the life of The Aon Ireland MasterTrust unless regulatory or legal obligations imposed on us require specific personal information to be retained for longer. We have implemented appropriate measures to ensure your personal information is securely destroyed in a timely and consistent manner when no longer required.

In specific circumstances we may store your personal information for longer periods of time so that we have an accurate record of your dealings with us in the event of any complaints or challenges, or if we reasonably believe there is a prospect of litigation relating to your personal information or dealings.

Some of them operate as separate <i>controllers</i>, and are responsible for their own compliance with data protection laws (for example they should issue their own privacy notices which you can refer to for more information about their practices). These activities could include any of the processing activities that we carry out as described in the above section, 'How we use your personal information.' <p>f) <b>Legal Requirements and Business Transfers:</b> We may disclose personal information (i) if we are required to do so by law, legal process, statute, rule, regulation, or professional standard, or to respond to a subpoena, search warrant, or other legal request. (ii) in response to law enforcement authority or other government official requests, (iii) when we believe disclosure is necessary or appropriate to prevent physical harm or financial loss, (iv) in connection with an investigation of suspected or actual illegal activity or (v) in the event that we are subject to a merger or acquisition to the new owner of the business, or if The Aon Ireland MasterTrust is transferred to another pension scheme, to the new trustees. Disclosure may also be required for company audits or to investigate a complaint or security threat.</p> <p><i>Data Categories: All Data Categories.</i></p>	✓	✓

### Do we transfer your personal information across geographies?

**Aon**, both in its capacity as a *controller* and where acting as a *processor* for **the Trustee** is a global organisation and may transfer certain personal information across geographical borders to **Aon's** authorised service providers or business partners in other countries working on **Aon's** behalf in accordance with applicable law. **Aon's** affiliates and third parties may be based locally or they may be overseas some of which have not been determined by the European Commission to have an adequate level of data protection.

When **Aon** does, we use a variety of legal mechanisms to help ensure your rights and protections travel with your data:

- we ensure transfers within Aon are covered by agreements based on the EU Commission's standard contractual clauses, which contractually oblige each member to ensure that personal information receives an adequate and consistent level of protection wherever it resides within;
- where we transfer your personal information outside of Aon or to third parties who help provide our products and services, we obtain contractual commitments from them to protect your personal information. Some of these assurances are well recognised certification schemes like the EU - US Privacy Shield for the protection of personal information transferred from within the EU to the United States, or the standard contractual clauses; or
- where we receive requests for information from law enforcement or regulators, we carefully validate these requests before any personal information are disclosed.

Examples of countries we transfer personal information to include, but are not limited to, the United States of America, the United Kingdom, Ireland, Singapore, India and the Philippines.

If you would like further information about whether your information will be disclosed to overseas recipients, please contact us as noted below. You also have a right to contact us for more information about the safeguards we have put in place (including a copy of relevant contractual commitments, which may be redacted for reasons of commercial confidentiality) to ensure the adequate protection of your personal information when this is transferred as mentioned above.

### **Do we have security measures in place to protect your information?**

The security of your personal information is important to us and we have implemented reasonable physical, technical and administrative security standards to protect personal information from loss, misuse, alteration or destruction. We protect your personal information against unauthorised access, use or disclosure, using security technologies and procedures, such as encryption and limited access. Only authorised individuals access your personal information, and they receive training about the importance of protecting personal information.

Our service providers and agents are contractually bound to maintain the confidentiality of personal information and may not use the information for any unauthorised purpose.

### **What choices do you have about your personal information?**

We offer certain choices about how we communicate with you. When you provide us with personal details, if **Aon** intends to use those details for marketing purposes, **Aon** will provide you with the option of whether you wish to receive promotional email, SMS messages, telephone calls and postal mail from us.

You may also choose not to receive marketing communications from **Aon** by clicking on the unsubscribe link or other instructions in marketing emails, visiting The Aon Ireland MasterTrust member website, or contacting us as noted below.

### **How can you update your communication preferences?**

#### *Profile*

You can update your contact information after you log into your account on The Aon Ireland MasterTrust member website.

#### *Other*

Contact us by e-mail or postal address as noted below. Please include your current contact information, the information you are interested in updating and your requested changes.

### **Other rights regarding your data**

Subject to certain exemptions, and in some cases dependent upon the processing activity we are undertaking, you have certain rights in relation to your personal information.

We may ask you for additional information to confirm your identity and for security purposes, before disclosing the personal information requested to you. We reserve the right to charge a fee where permitted by law, for instance if your request is manifestly unfounded or excessive.

You can exercise your rights by contacting us. Subject to legal and other permissible considerations, we will make every reasonable effort to honour your request promptly or inform you if we require further information in order to fulfil your request.

We may not always be able to fully address your request, for example if it would impact the duty of confidentiality we owe to others or if we are legally entitled to deal with the request in a different way.

#### *Right to Access*

You have a right to access personal information which we hold about you. You can access some of that information by visiting your account using The Aon Ireland MasterTrust member website.

#### *Right to Rectification*

You have a right to request us to correct your personal information where it is inaccurate or out of date.

#### *Right to be Forgotten (Right to Erasure)*

You have the right under certain circumstances to have your personal information erased. Your information can only be erased if your data is no longer necessary for the purpose for which it was collected, and we have no other legal ground for processing the data.

#### *Right to Restrict Processing*

You have the right to restrict the processing of your personal information, but only where:

- its accuracy is contested, to allow us to verify its accuracy; or
- the processing is unlawful, but you do not want it erased; or
- it is no longer needed for the purposes for which it was collected, but you still need it to establish, exercise or defend legal claims; or
- you have exercised the right to object, and verification of overriding grounds is pending.

We may still process your personal information without your consent to establish, exercise or defend legal claims, or in some other circumstances.

#### *Right to Data Portability*

You have the right to data portability, which requires us to provide personal information to you or another controller in a commonly used, machine readable format, but only where the processing of that information is based on (i) consent; or (ii) the performance of a contract to which you are a party.

#### *Right to Object to Processing*

You have the right to object to the processing of your personal information at any time, but only where that processing has our legitimate interests as its legal basis. If you raise an objection, we have an

opportunity to demonstrate that we have compelling legitimate interests which override your rights and freedoms.

### *Withdrawing consent*

Where your use of your personal information is only justified because you have given your consent to it, you can withdraw that consent at any time. However, this will not affect the processing of your personal information carried out before you withdrew consent.

### *International Transfers*

As noted above, you can ask to obtain a copy of, or reference to, the safeguards under which your personal information is transferred outside of Ireland and the European Economic Area.
